

KEY INFORMATION DOCUMENT CFD ON A COMMODITY (INC BULLION)

Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

Product

Contracts for difference on an equity (or share) are offered by **Axi Financial Services (UK) Ltd** ("Axi", "we", "our" or "us"), registered in England and Wales, under company number 06050593. What is this product?

This document relates to products known as contracts for difference which are more commonly referred to as **CFDs**. A CFD is a leveraged contract that an investor enters into with Axi on a bilateral basis and which allows speculation on rising or falling prices in an underlying commodity. A CFD on a commodity, including bullion, is where the underlying investment option that you choose is a commodity such as coffee, wheat or gold.

An investor can buy the CFD (or 'go long') if they think the value of the commodity will rise or sell the CFD (or 'go short') if they believe the value of the commodity will fall. The price of the CFD is derived from the price of the underlying commodity which may be the current ('cash') price or a forward ('futures') price. If an investor is long a gold CFD and the cash price of the underlying commodity rises, the value of the CFD will increase and at the end of the contract we will pay the difference between the closing value of the contract and the opening value of the contract. Conversely, if an investor is long a gold CFD and the end of the contract they will pay us the difference between the closing value of the closing value of the contract. A cash CFD does not have a pre-defined maturity date and is therefore open-ended.

A CFD on a commodity referencing the underlying futures price works in exactly the same way except that these contracts have an expiry date; a date upon which the contract automatically closes.

Objectives

The objective of the CFD is to allow an investor to gain leveraged exposure to the price movement in the underlying index. To open a position an investor is required to deposit a portion of the total value of the contract and this is referred to as the margin requirement. Trading on margin can enhance any losses or gains made.

For example, if an investor buys 1 CFD with a contract size of 100 and initial margin amount of 5% (or 20 to 1) and an underlying commodity price of 1274, the initial investment will be \$6,370.0 (5%*1274*100). However, the notional value of the contract is \$127,400 which shows the effect of leverage. Each 1 point change in the price of the underlying commodity results in the value of the CFD changing by \$1. If the investor is long and the market increases in value, a \$1 profit will be made for every 1 point increase in that market. If the market decreases in value however, a \$1 loss will be incurred for each point the market decreases. Conversely, if an investor holds a short position, a profit is made in line with any decrease in that market, and a loss for any increases in the market.

A negative price movement may lead to an increased margin balance and the requirement to add more funds. If an investor does not have sufficient funds in his account the CFD may be automatically closed ('liquidated').

Intended Retail Investor

CFDs are high risk products and therefore not appropriate for everyone. They are intended for investors who have experience with, or knowledge of, the financial markets and specifically the risks associated with trading leveraged products. They will likely be risk orientated and be trading with money they can afford to lose. Finally, they will normally be looking to gain short term exposures to these financial instruments and markets.

What are the risks and what could I get in return? Risk Indicator



The summary risk indicator is a guide to the level of risk of these products compared to other products. It shows how likely it is that the product will lose money because of movements in the markets.

We have classified these products 7 out of 7, which is the highest risk class. This rates the potential losses from future performance at a very high level.

There is no recommended minimum holding period for this product. The risk indicator assumes that you may not be able to close your CFD at the price you want due to market volatility or you have to close your CFD at a price that significantly impacts how much you get back.

Be aware of currency risk. You can trade CFDs that are denominated in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

In some circumstances you may be required to make further payments to pay for losses. In some circumstances, for example if you do not maintain the minimum margin that is required, your CFD will be liquidated (closed) automatically by us.

This product does not include any protection from future market performance so you could lose some or all of your investment. If, in the unlikely event, we are not able to pay you what is owed, you could lose your entire investment. However, you may benefit from a consumer protection scheme (see the section "what happens if we are unable to pay you"). The indicator shown above does not consider this protection.

Performance Scenarios

The scenarios shown below illustrate how your investment could perform. You can compare them with the scenarios of other products. The scenarios presented are an estimate of future performance based on evidence from the past on how the value of this investment varies, and are not an exact indicator. What you get will vary depending on how the market performs and how long you keep the investment/product. The stress scenario shows what you might get back in extreme market circumstances, and it does not take into account the unlikely situation where we are not able to pay you.

The following assumptions have been made to complete the scenarios in Table 1:

What are the costs?

The table shows the different types of costs involved when you trade a CFD on a commodity:

One off costs	Spread	The spread is the difference between the buy (ask) price and the sell (bid) price. For example, if the instrument is trading at a mid-price of 1274, our ask price (the price at which you can buy) might be 1274.2 and our bid price (the price at which you can sell) might be 1273.8. The full cost of the spread is realised each time you open and close a trade.			
Ongoing fees	Financing fees	In relation to cash products only: Financing fees (or 'interest', 'holding fees' or 'swaps') are charged on any open position held overnight. They will be credited or debited (as applicable) to your account at the close of the day. We calculate our financing charges on a daily basis using the applicable underlying bank rate +/- 2.5%. Charges are annualised and triple finance charges are charged on a Friday to reflect the charge over the weekend.			
	Swap fees	In relation to bullion only: The swap fee is charged on open positions held overnight. Your account will either be credited or debited with the swap fees based on open positions as at the close of each day. Swap fees accrue whilst a position remains open and are credited or debited to your account when the trade is closed. Swap fees are calculated in relation to the counter currency and are converted to and applied in the account currency.			
	Rollover fee	In relation to futures products only: The principle of the futures CFD rollover process is that traders will neither profit nor lose from the CFD rolling from the current underlying futures price to the next. You will be credited or debited with a rollover charge or swap benefit that reflects the buying and selling of the expiring and next underlying instrument contract. For example, if you have incurred a profit on the change to the new contract price you will receive a rollover charge which will offset the gain. If you incurred a loss on the change to the new contract price you will receive a swap benefit which will offset the loss. We typically switch from using the front month to the next serial futures contract 1-2 trading days prior to the underlying instrument's last trading day when liquidity can be limited.			
Incidental costs	Third party fees	Where applicable, we may share a proportion of the spread with the third party that has introduced you.			

How long should I hold it and can I take money out early?

CFDs are intended for short term trading and in some cases intraday; they are generally not suitable for long term investments. There is no recommended holding period for this product, no cancellation period and therefore no cancellation fees. You can open and close a CFD on a commodity at any time during market hours.
